must include full payment in order to be
included in the draw(s). No phone entries
will be accepted. USATT ratings as of Feb
12, 2010 will be used.

ELIGIBILITY: All players must be USATT
members. Please bring your USATT
membership card or receipt. Non-members
must join USATT at the tournament.
Unrated players may play in any singles
event, but unrated RR group winner will not
be allowed to advance.

DEFAULT POLICY: All ITTF/USATT
regulations apply. Wear dark, solid-colored
shirt and shorts, tennis shoes or sneakers.
Must abide by all USATT rules. Players not
registered within 10 minutes after starting
time of the event may be defaulted from
that event and without refund of entry fee. If
a rating event is canceled or has reached
its limit, player(s) will automatically be
placed in the next higher event.

REFUND POLICY: Players will be refunded
for entry fees at least one week prior to
tournament dates selected. Refunds will not

be given for any withdrawals after that date
except when the player's rating is too high
for a desired event and he or she chooses
not to be promoted to the next highest
event. No refund for no-show participants!
